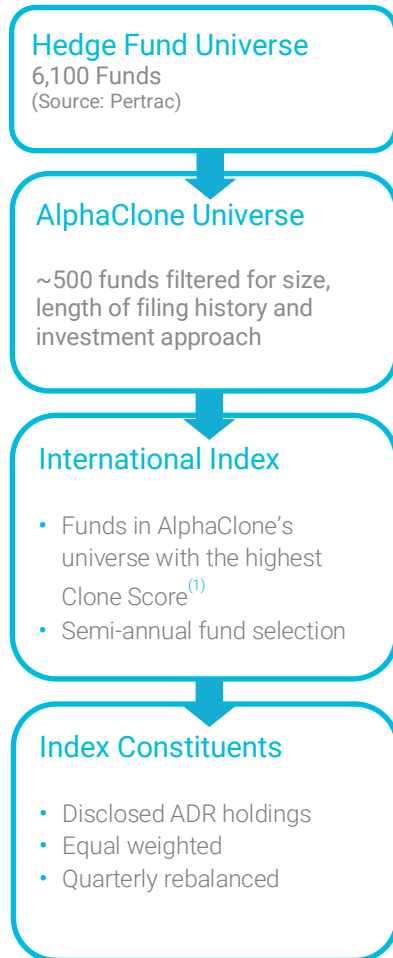


# AlphaClone International ETF (ALFI)

## Fund Description

The objective of the AlphaClone International ETF (ALFI) is to track the AlphaClone International Index before fees and expenses.

## Access to Hedge Fund Alpha Potential

Most investors can't conveniently access established hedge funds and the alpha potential from their investment ideas. However, hedge funds managing \$100 million or more must disclose their US publicly traded equity holdings on a form called 13F-HR which is filed quarterly and made available to the public. AlphaClone is a leader in researching managers based on their disclosures and has developed the AlphaClone International Index. The index uses AlphaClone's proprietary "Clone Score" methodology to aggregate on a quarterly basis American Depository Receipts (ADRs) disclosed by hedge funds for which historically it has made the most sense to follow based on their disclosures.

## Key Index Attributes

**Clone Score** – a proprietary scoring method that measures the efficacy of following a manager based on their public disclosures. AlphaClone's clone score for each manager is based on the monthly returns in excess of a broad market index and fixed hurdle rate exhibited by the manager's follow strategies over time. Clone scores are recalculated bi-annually.

**Weighting method** – Index constituents are equal weighted at each quarterly reconstitution.

- Access alpha potential from ADR investment ideas of established hedge funds
- Avoid hedge fund lockups and switching costs
